## 4. First Aid Measures

<b>Swallowed</b>	Do <u>NOT</u> induce vomiting. Rinse mouth with water. Give water to drink to achieve dilution. If symptoms persist call a POISON CENTRE or doctor/physician.
<b>Eye Contact</b>	Rinse cautiously with water for several minutes. Remove contact lenses if present and easy to do. Continue rinsing. If symptoms persist, contact a doctor/physician.
<b>Skin Contact</b>	Take off all contaminated clothing. Wash contaminated clothing before reuse. Rinse skin with water/shower.
<b>Inhaled</b>	Remove to fresh air and keep at rest in a position comfortable for breathing. If symptoms persist call a POISON CENTRE or doctor/physician.
<b>Advice to Doctor</b>	Treat symptomatically.

## 5. Fire-fighting Measures

<b>Specific Hazard</b>	Non-combustible material. The product may decompose in a fire giving off toxic carbon monoxide and nitrogen oxides.
<b>Suitable Extinguishing Media</b>	This product is non-combustible, if material is involved in fire use media appropriate for surrounding fire conditions. Safe to use water fog or water spray, foam, dry agent (carbon dioxide, dry chemical powder).
<b>Fire-fighting advice</b>	Non combustible, however following evaporation of aqueous component residual material can decompose if involved in a fire, emitting toxic fumes. If safe to do so, remove containers from path of fire. Fire fighters to wear self-contained breathing apparatus and suitable protective clothing if risk to exposure to products of decomposition.

## 6. Accidental Release Measures

Avoid walking through spilled product as it may be slippery. Stop leak if safe to do so. Do NOT let product reach drains or waterways. If contamination of sewers or waterways has occurred, advise local emergency services. Avoid accidents, clean up immediately. Wear protective equipment to prevent skin and eye contact. Soak up spilled product using absorbent non-combustible material such as sand or soil. Avoid using sawdust or cellulose. When saturated, collect material into suitable, clearly labeled, dry, sealable containers and hold for safe disposal. Once pick up is complete, flush spill site with plenty of water to eliminate any residue. Hold contaminated water for disposal by a waste disposal contractor

## 7. Handling and Storage

<b>Handling advice</b>	Before use, carefully read the product label. Avoid eye contact with concentrated material. Avoid breathing in vapours, mists and aerosols. Wash hands thoroughly after handling. Wear protective gloves, eye protection and overalls when handling bulk product. Contaminated work clothing should not be allowed out of the workplace after handling bulk product. Avoid release to the environment.
<b>Storage advice</b>	Store in a cool, dry, well ventilated area, away from direct sunlight, heat sources and food stuffs. Ensure containers are correctly labelled, protected from physical damage, sealed when not in use and stored upright. Check regularly for leaks, spills etc. Keep out of reach of children. Keep containers closed when not in use. Store in original packaging as approved by manufacturer. Do not use empty containers for the storage of foodstuffs.
